ARTICLES OF INCORPORATION

The undersigned, acting as Incorporators of this corporation, hereby adopt the following Articles of Incorporation for the purpose of forming a not-for-profit corporation under and by virtue of the laws of the State of Florida as contained in Chapter 617, Florida Statutes.

ARTICLE I. NAME

The name of the corporation shall be TANGLEWOOD VILLAGE SOCIAL CLUB, INC. and shall be located at 1060 S. US Highway 1, Vero Beach, Florida.

ARTICLE II. DURATION

The date of commencement of corporate existence shall be on the date the Articles are filed with the Department of State, and the period of duration of the corporation shall be perpetual.

ARTICLE III. PURPOSE AND POWERS

The specific and primary purposes for which the corporation is organized are:

A. To sponsor, support and conduct recreational and social activities for the residents of TANGLEWOOD VILLAGE, a manufactured housing community located in Vero Beach, Florida.
