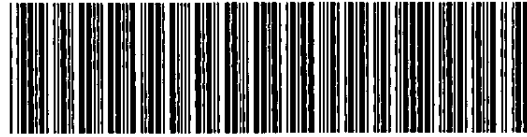

- h. The Florida Yeshiva University International Beth Midrash, Incorporated will have bank accounts signed by its President and Rosh has Yeshiva together with a signature of one of the other three members of the Board.

#### ARTICLE X ADDED

##### Incentive itself, public and private

- a. The Florida Yeshiva University International Beth Midrash, Incorporated, through its directory, manage along with individuals, communities, synagogues, public and private companies, to achieve funding of incentive to their programs of study and training, and for students who need help to continue their studies is satisfied.
- b. To the dissolution of The Florida Yeshiva University International Beth Midrash, Incorporated as a corporation will exist in perpetuity unless dissolved by law or provided for by the Statute of Florida 617.05. (or other statutes relating to such dissolution), and by majority, resulting decision of three ordinary sections. To the dissolution of this Corporation: all assets remaining after payment of the related obligations, will be donated to preferably Shema Israel Messianic Jewish Congregation Miami Inc., or any organization related that the Assembly and the directory decide, which have met the requirements for exemption under section 501.c of the internal revenue code. The directory will be responsible for this distribution.
- c. The dissolution of this Corporation, any part of its assets should be for the benefit of any particular individual or private organization, including members of the community, except in case of compensation for debts for services rendered.
