ARTICLES OF INCORPORATION OF OLD SOUTHEAST COMMUNITY GARDEN, INC.

A not- for- profit corporation

The undersigned person, acting as incorporator of a corporation not-for-profit under the Florida not-for-profit corporation act, as set forth in Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation for such corporation:

ARTICLE I Name

The name of this corporation is OLD SOUTHEAST COMMUNITY GARDEN, INC.

ARTICLE II Initial Principal Office

The street address of the initial principal office of the corporation shall be 1 Beach Drive SE, #2314, St. Petersburg, FL 33701.

ARTICLE III Objects and Purposes

The corporation is organized exclusively for charitable, educational, or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, as it now exists or as amended (the "Code), more specifically:

- A. To operate a Community Garden to grow vegetables or flowers for the community, to preserve green space and to create opportunities for recreation.
- B. To purchase or sell, hypothecate, mortgage and lease such real and personal property as may be necessary for the purpose of the Corporation, and to execute deeds, contracts, agreements and obligations, the purposes whereof are consonant with the

laws of the State of Florida under which this Corporation is formed, and to accept and execute any trust; the purpose whereof is lawful and to do each and everything necessary, suitable or proper for the accomplishment of any of the purposes herein enumerated, or which may at any time appear conductive or expedient for the benefit or protection of the corporation.

- C. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- No part of the net earnings of the corporation shall inure to the benefit of, or be D. distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- E. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for the public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the corporation is then located, exclusively for the purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IV Membership

The members of the corporation shall be those persons who subscribe to the rules,

regulations, usages and usages of this corporation.

ARTICLE V Term of Existence

This corporation shall have perpetual existence.
