

ARTICLES OF INCORPORATION

OF



KOREAN PRESBYTERIAN CHURCH OF GAINESVILLE, INC.

(a corporation not for profit)

ARTICLE I - NAME

The name of this corporation is KOREAN PRESBYTERIAN CHURCH OF GAINESVILLE, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of this corporation is 1521 NW 34th Street, Gainesville, FL 32605.

ARTICLE III - DURATION

This corporation shall have perpetual existence.

ARTICLE IV- PURPOSE

The purpose of this corporation is to function as a church. This non-profit corporation is formed to provide worship services and to enhance the knowledge of the Holy Scriptures to any willing person or people. This corporation will engage in any lawful act or activity for which corporations may be organized under the Florida Not For Profit Corporation Act, Florida Statute chapter 617.

All assets of the corporation shall be principally and directly dedicated exclusively to religious and educational work. The corporation shall not engage in business activities for profit and no part of any net earnings of the corporation shall inure to the benefit of any member, director or officer of the corporation, or any private individual, save and except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes, and no member, director or officer of the corporation, or private

individual, shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation. No substantial part of the activities of the corporation shall be the carrying on of secular propaganda, or otherwise attempting to influence legislation.

Notwithstanding any other provision of these articles, the corporation shall not conduct or carry on any activities not permitted by an organization except under Section 501C(3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended, or by any organization contributions to which are deductible under Section 170C(2) of such Code and regulations.

Upon the dissolution or liquidation or other winding up of this corporation, all of its assets, principal and income, subject to the payment of its debts, shall be distributed to an organization which is exempt under Section 501C(3) of the Internal Revenue Code.

ARTICLE V - MEMBERSHIP

This corporation shall not have any capital stock, and the conditions of membership shall be stated in the Bylaws.

ARTICLE V- INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of this corporation is 1521 NW 34th Street, Gainesville, FL 32605 and the name of the initial registered agent of this corporation at that office is Choong Hong Kim.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

The civil activities and affairs of the corporation shall be managed by a board of directors. The number of directors which shall constitute the whole board shall be such as from time to time shall be fixed by, or in the manner provided in the Bylaws, but in no case shall the number be less than three. The directors need not be members of the corporation unless so required by the Bylaws. The board of directors shall be elected by the members at the annual meeting of the corporation to be held on such date as the Bylaws may provide,

and shall hold office until their successors are respectively elected and qualified. The Bylaws shall specify the number of directors necessary to constitute a quorum. The board of directors may, by resolution or resolutions, passed by a majority of the whole board, designate one or more committees, which to the extent provided in said resolution or resolutions or in the Bylaws of the corporation shall have and may exercise all the powers of the board of directors in the management of the activities and affairs of the corporation and may have power to authorize the seal of the corporation to be affixed to all papers which may require it; and such committee or committees shall have such name or names as may be stated by the board of directors. The directors of the corporation may, if the Bylaws so provide, be classified as to term of office. The corporation may elect such officers as the Bylaws may specify, who shall, subject to the provision of the statute, have such titles and exercise such duties as the Bylaws may provide.

This corporation may in its Bylaws confer powers upon its board of directors in addition to the foregoing, and in addition to the powers and authorities expressly conferred upon them by statute.
