ARTICLE I NAME

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

This Corporation is a social welfare organization to be operated exclusively as a not-for-profit entity for purposes within the meaning of IRC §501(c)(3) of the Internal Revenue Code of 1986, as amended to develop poetry as a cultural movement and stewardship in terms of pride in the Spirit and encourage the close relationships and build a civilization of the peoples; to unite the efforts of the members and coordinate among them to create the appropriate cultural climate in member countries that belong to the Union to highlight the capabilities of innovators through development and sponsorship; to organize and hold seminars and meetings concerning poetic, literary and cultural projects and serve the cultural and civilizational movement in the Member States in the framework of the Union's to enhance meetings, poetic and literary dialogues and promote cultural and civilizational worldwide rapport; and to promote openness and acceptance of all world cultures and participate in events carried out by similar groups in the world.




