This Corporation is a social welfare organization to be operated exclusively as a not-for-profit entity for purposes within the meaning of IRC §501(c)(3) of the Internal Revenue Code of 1986, as amended: To encourage and support intellectual actions and projects, through creative and media excellence, which serve the Arab consciousness and the process of reform and constructive and tolerant trend.
