ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF LDOR VADOR DEVELOPMENT CORPORATION

Pursuant to the provisions of Section 617.1006 of the Florida Not-for Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The Articles of Incorporation of LDOR VADOR DEVELOPMENT CORPORATION (the "Corporation"), were filed on December 26, 2013 and assigned document number N13000011387.

SECOND: The Articles of Incorporation of the Corporation are hereby amended in the following manner:

Article III is hereby deleted in its entirety and replaced by the following:

"Article III

The purpose of the Corporation is to engage in charitable, religious and educational activities within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any future United States internal revenue law (the "Code"), that support, benefit and carry out the purposes of that class of publicly supported charities, as defined in Sections 509(a)(1) and 509(a)(2) of the Code, that conduct or support Jewish education.

The following Article VIII is hereby added:

"Article VIII

The property of the Corporation is dedicated to charitable, religious and educational purposes, and no part of the net income or assets of the Corporation shall ever inure to the benefit of any director, officer or member, if any, of the Corporation, or any other private person. Upon the winding up and dissolution of the Corporation and after paying or adequately providing for the debts and obligations of the Corporation, the remaining assets shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated for charitable, religious or educational purposes within the meaning of Section 501(c)(3) of the Code and which is part of that class of publicly supported charities, as defined in Sections 509(a)(1) and 509(a)(2) of the Code, that conduct or support Jewish education.

THIRD: Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.

FOURTH: The amendments herein provided for were approved and adopted by a majority vote of the members of the board of directors of the Corporation on January 1, 2014.
