# Amended 1/18/2021

### Article III (Amended)

The purpose of the Corporation is to promote the development of strong character, a right attitude, and a sense of responsibility and citizenship in youngsters, using the game of baseball as a vehicle, and in furtherance thereof, to promote fair play, good sportsmanship and congenial fellowship, with adult leaders providing the example through baseball leagues organized for youngsters. Without limitation by virtue of the preceding sentence, the purpose of the Corporation will include the conduct of any or all lawful affairs, not required to be specifically stated herein, for which corporations may be incorporated. However, notwithstanding anything herein to the contrary, the Corporation will not carry on any activity not permitted to be carried on by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1954 or any corresponding future provision of the Revenue Code, and the Corporation will not attempt to influence legislation by propaganda or otherwise, nor will it intervene in, or participate in, any political campaign on behalf of any candidate for public office, and provided further that no part of the net earnings of this Corporation will inure to the benefit of any member or private individual and no member, director, or officer of the Corporation will receive any pecuniary benefit from the Corporation, except such reasonable compensation as may be allowed for Services actually rendered to the Corporation.

#### Article IX (Added)

In the event of the dissolution of the Corporation, the balance of all money or other property received by the Corporation from any source, after the payment of all debts and obligations of the Corporation, will be used or distributed exclusively for purposes within the intent of section 501 (c) (3) of the Internal Revenue Code as the same now exists or it may be amended from time to time.
