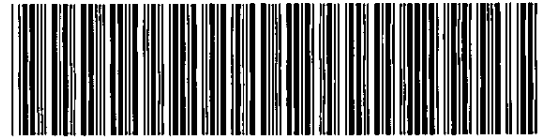



**ATTACHMENT TO ARTICLES OF AMENDMENT
OF
THODOS FAMILY FOUNDATION, INC.**

ARTICLE II – PURPOSE is hereby deleted in its entirety and replaced by the following:

The Corporation is organized exclusively for charitable, educational, religious or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Charitable purposes may include the making of distributions to organizations qualifying as exempt organizations under Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future federal tax code.

ARTICLE IV – LIMITATION OF CORPORATE POWERS is hereby amended by adding the following as a new paragraph under the existing paragraph therein:

The Corporation will distribute its income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code, or the corresponding provision of any future federal tax code. The Corporation will not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code, or the corresponding provision of any future federal tax code. The Corporation will not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code, or the corresponding provision of any future federal tax code. The Corporation will not make any investments in such manner as to subject it to tax under Section 4944 of the Internal Revenue Code, or the corresponding provision of any future federal tax code. The Corporation will not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code, or the corresponding provision of any future federal tax code.
