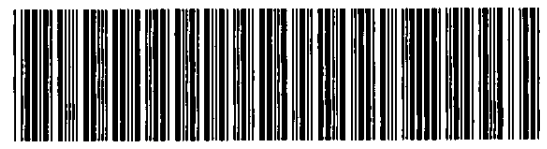

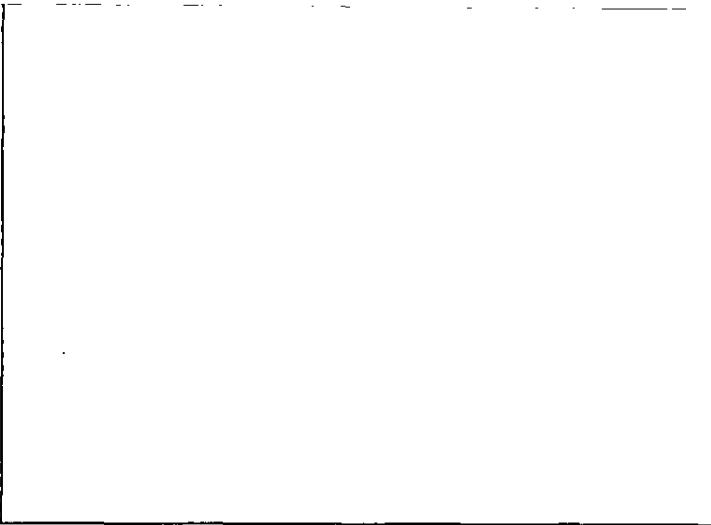

ARTICLES OF INCORPORATION
For
Water for the Journey Life Coaching Academies, Inc.

Articles of Incorporation of the undersigned, of whom are citizens of the United States, desiring to form a Non-profit Corporation under the Non-profit Corporation Law of State of Florida, do hereby certify:

ARTICLE I

The name of the corporation shall be Water for the Journey Life Coaching Academies, Inc.

ARTICLE II

The place in this State where the principal office of the corporation is to be located is 710 S. Love Street, Quincy FL 32351

ARTICLE III

Said corporation is organized exclusively for faith-base, charitable, social, educational, spiritual and human services purposes, activities and programs of mentoring, prevention of recidivism, life coaching and case management; including residential services, the owning and leasing of property for the purpose of service delivery to people formerly incarcerated and or their immediate family members, and for the purpose of and or alternative placement and or services to incarceration; to provide mentoring and life coaching services to general population (adults, children, professionals) for the purpose of improving their quality of life through the use of education, empowerment, and prevention education; the making of distributions to other organizations that qualify as exempt organizations under section 501 (c) (3)Of the Internal Revenue Code, or the corresponding section of any future federal tax code; and the collaboration with for profit or not for profit, educational, faith-base and other community based organizations, as necessary to deliver said services.

ARTICLE IV

All directors are elected by a majority vote, with the exception of the founder, who is allowed to serve indefinitely, except as noted in the bylaws.

ARTICLE VIII

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article three (3) hereof. No substantial part of activities of the corporation shall be carrying propaganda, or otherwise attempting to influence legislation, and the corporation shall participate in or intervene in (publishing or distribution of statements). Any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue code, or corresponding section of any federal tax code.

ARTICLE IX

The corporation shall be organized on a non-stock basis.

Upon dissolution of the corporation, assets, not restricted by other arrangements between donor and this corporation shall be distributed for one or more exempt purposes within the meaning of 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed back to FAITH, INC for public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the parish in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which is organized and operated exclusively for such purposes.


ARTICLE X

This Corporation shall have the power to indemnify and defend who was or is threatened to be a party to any pending or threatened action, suit, or proceeding, whether criminal, administrative, or investigative, (other than an action by the corporation). By reason of the fact that he is or was a Trustees, officer, or employee or is serving at the request of the corporation as a Trustee , officer or employee or agent from another corporation or entity, against expenses, including attorney fees judgments, fines, and amounts paid in settlement actually and reasonably incurred by him in connection with such action if he acted in good faith and in a manner he reasonably believed to be in , or not opposed to the best interests of the corporation and had no reason to believe his/her conduct was unlawful.



With respect to a criminal proceeding the individual must have had no reasonable cause to believe his or her conduct was unlawful




