

ARTICLES OF INCORPORATION 97 SCP 30

LAKE WALES ESTATES LAND AND HOMEOWNER'S ASSOCIATION, INC. AMENDED AND RESTATED NOVEMBER 30 1996

THE UNDERSIGNED SUBSCRIBERS OF THESE ARTICLES OF INCORPORATION, EACH A NATURAL PERSON COMPETENT TO CONTRACT, HEREBY VOLUNTARILY ASSOCIATE THEMSELVES TOGETHER TO FORM A CORPORATION NOT FOR PROFIT, UNDER THE LAWS OF THE STATE OF FLORIDA, AND DO HEREBY CERTIFY:

ARTICLE I- NAME

THE NAME OF THE CORPORATION SHALL BE; LAKE WALES ESTATES LAND AND HOMEOWNER'S ASSOCIATION, INC. THE PRINCIPAL PLACE OF BUSINESS SHALL BE 3665 LAKE WALES ESTATES, 4930 SAND DOLLAR ST. LAKE WALES, FLORIDA 33853. THIS CORPORATION IS REFERRED TO HEREIN AS THE ASSOCIATION.

ARTICLE II- PURPOSE

THE PURPOSE FOR WHICH THIS NON-PROFIT CORPORATION IS FORMED IS THE OPERATION OF LAKE WALES ESTATES LAND AND HOMEOWNER'S ASSOCIATION, INC.

ARTICLE III-MEMBERSHIP

THE MEMBERS OF THE ASSOCIATION SHALL CONSTITUTE ALL OF THE CURRENT DUES PAYING OWNERS IN LAKE WALES ESTATES LAND AND HOMEOWNER'S ASSOCIATION, INC. ADMISSION TO MEMBERSHIP SHALL BE ESTABLISHED BY THE RECORDING IN THE PUBLIC RECORDS OF POLK COUNTY, FLORIDA. A DEED OR OTHER INSTRUMENT ESTABLISHING A RECORD TITLE TO THE HOME AND/OR PROPERTY AND THE DELIVERY TO THE ASSOCIATION OF A CERTIFIED COPY OF SUCH INSTRUMENT, WHICH INSTRUMENT SHALL REFLECT THE PRIOR APPROVAL OF THE ASSOCIATION AS REQUIRED BY THE RESPECTIVE DECLARATION. UPON RECEIPT OF SUCH A CERTIFIED COPY, THE OWNER OF EACH HOME AND PROPERTY SHALL BE ENTITLED TO AT LEAST ONE VOTE AS A MEMBER OF THE ASSOCIATION. THE EXACT NUMBER OF VOTES TO BE CAST BY OWNERS OF A HOME AND/OR PROPERTY AND THE MANNER OF EXERCISING VOTING RIGHTS SHALL BE DETERMINED BY THE BY-LAWS OF THE ASSOCIATION.

ARTICLE IV

THIS CORPORATION SHALL EXIST PERPETUALLY, COMMENCING ON THE DATE OF DECEMBER 13, 1985.

ARTICLE V- DIRECTORS

THE AFFAIRS OF THE ASSOCIATION SHALL BE MANAGED BY A BOARD OF DIRECTORS IN A NUMBER DETERMINED BY THE BY-LAWS, BUT NOT LESS THAN FIVE (5) DIRECTORS SHALL BE AUTHORIZED. IN THE ABSENCE OF ANY DETERMINATION, THE BOARD SHALL CONSIST OF FIVE (5) DIRECTORS. MEMBERS OF THE BOARD OF DIRECTORS SHALL BE ELECTED, HOLD OFFICE AND BE REMOVED AND REPLACED IN THE MANNER PROVIDED BY THE BY-LAWS.

THE BOARD OF DIRECTORS SHALL BE ELECTED IN NOVEMBER OF EACH YEAR AND SHALL SERVE A ONE YEAR TERM. SERVING AS THE BOARD OF DIRECTORS UNTIL THAT TIME ARE:

ARTICLE IX-BY-LAWS

AFTER APPROVAL BY THE PRESIDENT AND BOARD, THE PROPOSED AMENDMENT SHALL BE SUBMITTED TO THE MEMBERS OF THE ASSOCIATION FOR PASSAGE, WHICH SHALL BE BY MAJORITY VOTE.

ARTICLE XI- POWERS OF CHAIRMAN

THE PRESIDENT IS LIMITED TO THE OWNER OR OWNERS OF THE ASSOCIATION AND IS A PERMANENT POSITION NOTE: SUBJECT TO REMOVAL BY MEMBERS OF THE BOARD OF DIRECTORS IN A QUORUM VOTE.

THE PRESIDENT SHALL HAVE THE POWER FOR;

A. VETO RIGHTS FOR ALL ACTION EXCEPT THOSE PASSED BY MAJORITY VOTE.

B. IN AN EMERGENCY, THE PRESIDENT SHALL HAVE THE POWER TO APPOINT AN OFFICER OR BOARD MEMBER, UNTIL THE ASSOCIATION THROUGH NORMAL PROCEDURES PROCURES A PERMANENT INDIVIDUAL TO FILL THE VACANT OFFICE.

C. THE BOARD, OFFICERS OR MEMBERS SHALL NAVE NO CONTROL OR VOICE IN THE OWNER'S UTILIZATION OF THE PROPERTY ON WHICH THE ASSOCIATION IS LOCATED.
