

**AMENDMENTS TO THE RESTATED
ARTICLES OF INCORPORATION OF TRUMP PLAZA OF THE PALM
BEACHES CONDOMINIUM ASSOCIATION, INC.**

Article I, Article II, and Article III, of the Restated Articles of Incorporation are amended to read as follows:

ARTICLE I
NAME

The name of the corporation shall be ~~Trump~~The Plaza of the Palm Beaches Condominium Association, Inc. For convenience, the corporation shall be referred to in this instrument as the "association," or the "corporation," these articles of incorporation as the "articles," and the by-laws of the association as the "by-laws."

ARTICLE II
PURPOSE

The purpose for which the association is organized is to provide an entity pursuant to the Florida Condominium Act (the "Act") for the operation of the condominium established within the property as legally described on exhibit "A" hereto. The foregoing land is sometimes referred to as the "~~Trump~~The Plaza complex land," and the condominium therein sometimes referred to as the "~~Trump~~The Plaza complex" or the "complex." The condominium submitted to condominium ownership in the ~~Trump~~The Plaza complex which these articles shall govern, is known as "~~Trump~~The Plaza of the Palm Beaches, a Condominium." Whenever reference is made in these articles to the "condominium", it shall be deemed to be referring to ~~Trump~~The Plaza of the Palm Beaches, a Condominium.

ARTICLE III
DEFINITIONS

The terms used in these articles shall have the same definitions and meaning as those set forth in the declaration of condominium of ~~Trump~~The Plaza of the Palm Beaches, a Condominium, and the by-laws of the association, unless herein provided to the contrary, or unless the context otherwise requires. Whenever reference is made in these articles to the "declaration" or to the "declarations," it shall be deemed to be referring to the declaration of condominium of ~~Trump~~The Plaza of the Palm Beaches, a Condominium, and the declaration of condominium for such other condominium or condominiums, if any, which are subsequently to be determined to be operated by the association.
