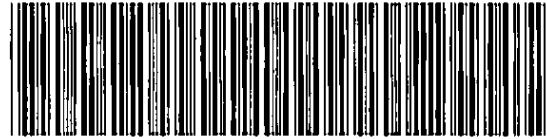

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is: Howell Cove Homeowners Association, Inc. and the initial principal address of the corporation is: 3713 Jericho Drive Casselberry, FL 32707.

ARTICLE II
