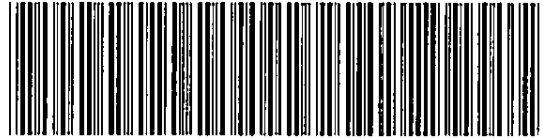

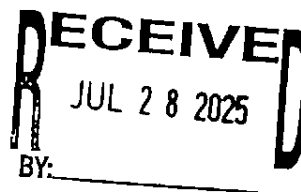

**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
OF
GULFCOAST HOUSING FOUNDATION, INC.**

The undersigned, as an officer of GULFCOAST HOUSING FOUNDATION, INC., a Florida not for profit corporation (the "Corporation"), desiring to amend the Articles of Incorporation of the Corporation pursuant to the terms of Sections 617.1001 and 617.1002, Chapter 617, Florida Statutes, the Florida Not For Profit Corporation Act (the "Act"), states as follows:

1. The current name of the Corporation is GULFCOAST HOUSING FOUNDATION, INC.
2. The date of the filing of the original Articles of Incorporation of the Corporation with the Florida Department of State was February 24, 1986.
3. Paragraph (a) of Article IV of the Articles of Incorporation of the Corporation is hereby amended and restated in its entirety, as follows:
 - (a) To foster low-income housing across the State of Florida by owning, developing, and investing its funds, through its affiliates and subsidiaries, in affordable housing communities.
4. Except as modified by these Articles of Amendment to Articles of Incorporation of the Corporation, the Articles of Incorporation of Gulfcoast Housing Foundation, Inc. shall remain the same and in full force and effect.
5. This amendment was adopted by the members of the Corporation and the number of votes cast for the amendment were sufficient for approval.
6. The foregoing amendment was adopted on April 22nd, 2025.
