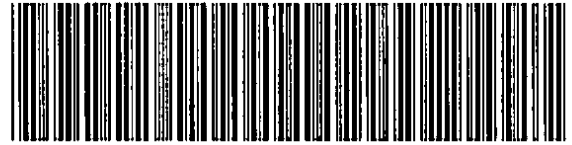

CERTIFICATE OF AMENDMENT

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF SARASOTA EASTPOINTE HOMEOWNERS ASSOCIATION, INC. DOCUMENT NUMBER OF CORPORATION: N13818

Pursuant to provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

1. The Articles of Incorporation have been amended as follows:

Article XI, Section B. A resolution approving a proposed amendment may be proposed by the Board of Directors or by the members of the Association. ~~Members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, provided such approval is delivered to the Secretary at or prior to the meeting.~~ Members may vote at the meeting considering the proposed amendment in person or by limited proxy, provided the proxy is delivered to the Association prior to the vote being taken at the meeting. Except as elsewhere provided, such approvals must be by not less than a majority of the Lot Owners that are present in person or by proxy at the meeting at which the amendment is considered ~~two-thirds (2/3) vote of the Residential Unit Owners.~~

2. The date of adoption of the amendment was January 9, 2020, and it is effective upon recording in the Public Records of Sarasota County, FL.

3. The amendment was approved and adopted by the members of the Association and the number of votes cast for the amendments were sufficient for approval.
