> To make, amend, and enforce reasonable rules and regulations governing the use of the units, common elements and Association Property, the operation of the Association, and including the frequency, time, location, notice and manner of the inspection and copying of official records.

(a) Any rule and regulation regarding the use of the Unit, other than that relating to architectural control, may not be made by the Board of Directors alone. Instead, such regulations may be adopted only by amending one of the Condominium Documents, and obtaining the vote required by the particular Condominium Document involved.
