AMENDED AND RESTATED ARTICLES OF INCORPORATION OF JAN R, LEWIS PHILANTHROPIC FUND INC.

(A Florida Not-For-Profit Corporation)

ARTICLE I.

NAME

The name of the corporation shall be JAN R. LEWIS PHILANTHROPIC FUND INC. (the "Corporation").

ARTICLE II.

PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and the mailing address of the Corporation shall be 4000 Ponce de Leon Blvd., Suite 510, Coral Gables, Florida 33146.

ARTICLE III.

<u>PURPOSE</u>

This Corporation is a not-for-profit corporation, organized and to be operated exclusively for charitable purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code of 1988, as amended (the "Code"), and not for pecuniary profit. More specifically, the Corporation is organized and shall be operated exclusively to carry out the following purposes:

- (a) To support and promote the arts, education, religion, medical research, animal rights and green environment efforts throughout the world; and
- (b) To carry on such other activities in furtherance of the foregoing purposes as are lawful and proper for corporations formed under the Florida Not-for-Profit Corporation Act and exempt from federal income tax under section 501(c)(3) of the Code.

ARTICLE IV.

<u>MEMBERSHIP</u>

The Corporation shall have no members.

ARTICLE V.

INITIAL REGISTERED OFFICE AND AGENT

The street address of the Initial registered office of the Corporation is 4000 Ponce de Leon Blvd., Suite 510, Coral Gables, FL 33148, and the name of the Corporation's initial registered agent at that address is Jan R. Lewis.

ARTICLE VI.

BOARD OF DIRECTORS

The affairs of this Corporation shall be managed by a Board of Directors. The number of directors shall initially be four. The number of directors may be increased or decreased from time to time as set forth in the Bylaws of the Corporation, but shall never be less than three. The manner of election of members of the Board of Directors shall be as set forth in the Bylaws of the Corporation. DISSOLUTION

Upon the dissolution of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a not-for-profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax-exempt status under section 501(c)(3) of the Code (or the corresponding provision of any future federal tax laws), as selected by the Board of Directors.

ARTICLE X.

LIMITATIONS

No part of the net earnings of the Corporation shall inure to the benefit of its directors, officers or other private persons, except that the Corporation shall be authorized to pay reasonable compensation for services rendered and to make payments in furtherance of any of its charitable purposes. No part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise

of section 501 of the Code), and the Corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Code (or the corresponding provision of any future federal tax laws), or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Code (or the corresponding provision of any future federal tax laws).

The Amended and Restated Articles were unanimously authorized and directed by Unanimous Written Consent to Corporate Action by the Board of Directors of the Corporation dated as of June 11, 2014. The Corporation does not have members. All other provisions of the Articles of Incorporation of the Corporation, as heretofore amended, shall remain in full force and effect without any modification thereof.
