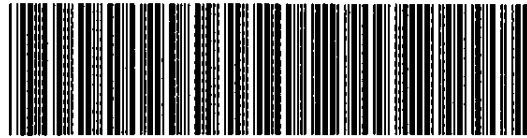





Upon dissolution of the organization, the assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the internal revenue code or corresponding section of any future federal tax code or shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes, or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.
