The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation Law of <u>State of Florida</u>, do hereby certify:

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

The purpose of the corporation called JEOP Evangelistic Outreach Ministry Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The corporation is further formed a religious organization a church to; cultivate, promote, and promulgate the teachings and precepts of Jesus Christ and help the needy in society. corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or the corresponding section of any future federal tax code.
