ARTICLES OF INCORPORATION

FOR

SCHOLARS ROCK, INC.

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of **FLORIDA**, as set forth in Chapter 617 of the Florida Statutes, do hereby certify and adopt:

ARTICLE I: NAME

The name of the Corporation shall be **SCHOLARS ROCK**, **INC.**, hereinafter referred to the "Corporation".

ARTICLE II: PRINCIPAL OFFICE & MAILING OFFICE

The mailing address and the address of the principal office is ONE LAS OLAS CIRCLE, SUITE 1407, FORT LAUDERDALE, FL 33316.

ARTICLE III: PURPOSE

The purpose for which this Corporation is organized is to build and support college-going cultures in communities and schools.

The Corporation is exclusively for charitable, religious, educational, or scientific purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV: ADDITIONAL PROVISIONS

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

DIVISION OF CORPORATIONS

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III of this document and in Section 501(c)(3) of the Internal Revenue Code.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE V: DISSOLUTION OF ASSETS

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLE VI: MANNER OF ELECTION

The directors will be elected and appointed in accordance with the Corporation's bylaws.
