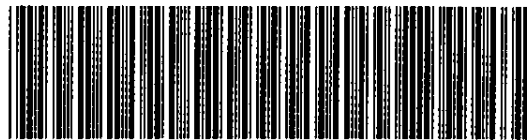

ARTICLES OF INCORPORATION
HOPEWELL CHURCH CEMETERY FOUNDATION, INC.
A FLORIDA NONPROFIT CORPORATION

The undersigned, desiring to form a non-profit corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

Article I
Name of the Corporation.

The name of the Corporation is Hopewell Church Cemetery Foundation, Inc.

Article II
Principal Office of the Corporation.

The street address of the initial principal office of the Corporation is 114 E. Davis Blvd., Unit 2, Tampa, FL 33606. The initial mailing address of the Corporation is the same as the initial street address of the principal office of the Corporation.

Article III
Purposes of the Corporation.

The Corporation is organized exclusively for the purpose of receiving and holding funds in trust for the perpetual care and maintenance of Hopewell Church Cemetery, located in Tampa, Florida. The income of the Corporation shall be devoted exclusively to the perpetual care, maintenance, and improvement of Hopewell Church Cemetery. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay ordinary and necessary expenses in connection with the operation, management, maintenance and improvement of Hopewell Church Cemetery and the reasonable fees for the services of a manager.

Article IV
Manner of Election of Directors.

The method of election of the Directors of the Corporation shall be stated in the bylaws of the Corporation

Article VI

Registered Office and Registered Agent.

The street address of the Corporation's initial registered office is 500 E. Kennedy Blvd., Ste. 100, Tampa, Florida 33602. The Corporation's initial registered agent is Bruce S. Goldstein

Article VII

Incorporators.


