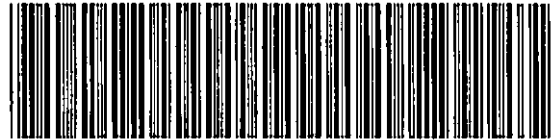



Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not for Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

**Item I**

Article I of the Certificate of Incorporation is hereby amended by deleting it in its entirety and by substituting it with the following:

“ARTICLE I

The name of the Corporation is: ELEVAR FOUNDATION, INC.”

**Item II**

Article III of the Certificate of Incorporation is hereby amended by deleting it in its entirety and by substituting it with the following:

“ARTICLE III

The specific and exclusive charitable purpose for which this Corporation is organized is to provide music education to aspiring, underprivileged and at-risk segments of the population, in the form of free or low-cost masterclasses, performances, instrument donations, workshops and community-engagement training for the next generation of violinists with the overarching goal of promoting violin performance and inspiring young artists to become community advocates for classical arts.”

There are no Members. The amendments were approved by the unanimous consent and agreement of the officers and directors of the corporation. The number of votes cast for the amendment by the officers and directors were sufficient for approval.
