

NATIONAL AMERICAN OUTREACHE FOUNDATION INC.



Notwithstanding any other provision of these articles, the corporation is organized exclusively for one or more of the purposes as specified in section 501 (c) (3) of the Internal Revenue Code of 1954, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal Income Tax Under Internal Revenue Code Section 501 (c) (3) or corresponding provisions of any subsequent Federal Tax Laws.
- k. No part of the net earnings of the Corporation shall insure to the benefit of any member, trustee, director, officer of the corporation, or any private individual (except that reasonable compensation maybe paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation or any individual shall be entitled to share in the distribution of any of the corporate assets on dissolutions of the corporation.
- 1. No substantial part of the activities of the corporation shall be carrying in propaganda, (except as otherwise provided by Internal Revenue Code Section 501 (h) or participating in or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.


