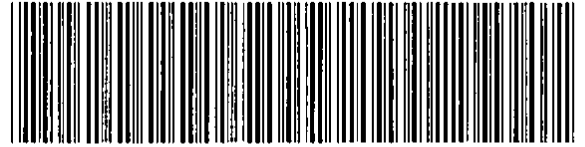

**ARTICLE III: STATEMENT OF CORPORATE PURPOSES**

The objectives of NAOF are,

- B. NAOF as a Faith oriented organization, will focus in unifying Abrahamic and non-Abrahamic religions around the world. - C. The NAOF will promote historical and cultural achievements based upon Religious and Cultural Traditions and Values, with special reference to the accomplishments of the above stated minority communities.
- D. NAOF's goal is to serve Sephardi, Mizrahi and UltraOrthodox Jewish communities. Being a Faith, educational and charitable oriented organization our focus will be on projects directed to these communities and traditions. NAOF will focus in Projects for Ultraorthodox and Orthodox Jewish Communities and other Abrahamic Communities like Muslims or Shiites. The purposes is unifying Abrahamic and non-Abrahamic religions around the world, with the main purpose of bringing peace to our families and communities.
- E. The NAOF will provide Community Service Recognition Awards to the above stated minority communities.
- F. NAOF will provide, implement, and execute educational projects to the community about immigration, family counseling, financial counseling, child support, first time home buyers, domestic violence, and human trafficking prevention, business guide for first time home buyers, entrepreneurs that includes general information on loans, grants and other social interest and needs. NAOF will provide, implement, and execute educational projects to the community about local and global sources of energy, water, food, population, poverty, arts, culture, environment, health, technology, democracies, among other social interests and needs. To raise the economic, social, and health awareness of their members.
- G. NAOF is a Florida Charitable non-profit corporation organized to operate exclusively to receive donations of any kind in any lawful manner from the general public.
- H. NAOF To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, association, trusts, institutions, foundations, or governmental bureaus, departments or agencies.

- H. NAOF as a Faith oriented organization, we will focus on Projects for Ultraorthodox and Orthodox Jewish Communities and other Abrahamic Communities like Muslims or Shiites. The purposes again is unifying Abrahamic and non-Abrahamic religions around the World. And to raise the economic, social, and health awareness of their members.
- I. The organization will conduct activities which are exclusively charitable and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1954, as the same may be amended from time to time.
- J. In furtherance of the foregoing purposes, the corporation shall have all of the general power enumerated in sections of the Not – for-Profit Corporation Law together with the power to solicit grants and contributions for any corporate purposes.
- K. Notwithstanding any other provision of these articles, the corporation is organized exclusively for one or more of the purposes as specified in section 501 (c) (3) of the Internal Revenue Code of 1954, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal Income Tax Under Internal Revenue Code Section 501 (c) (3) or corresponding provisions of any subsequent Federal Tax Laws.
- L. No part of the net earnings of the Corporation shall insure to the benefit of any member, trustee, director, officer of the corporation, or any private individual (except that reasonable compensation maybe paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation or any individual shall be entitled to share in the distribution of any of the corporate assets on dissolutions of the corporation.
- M. In the event of dissolution, all of the remaining assets and property of the corporation shall, after necessary expenses thereof, be distributed to another UltraOrthodox Jewish organizations in the State of New York, or Sephardi & Mizrahi Orthodox Jewish in the State of California exempt under Internal Revenue Code Section 501 (c) (3).
