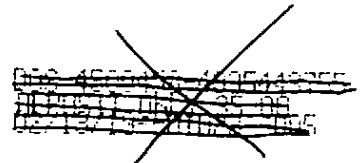

***ARTICLE I***

**NAME**

The name of this corporation shall change from Pink Strydes, Incorporated to Abba Ark of Hope Inc hereafter "Corporation" effective 03/01/2019 as voted on and approved by the Board of Directors. The principal office or headquarters for the transaction of business shall be located at 3144 EL Camino Real, West Palm Beach, FL 33409, located within the County of Palm Beach and State of Florida. The Abba Ark of Hope shall have and shall continuously maintain corporation status in the State of Florida as a registered office and agent.

***ARTICLE II***  
**DURATION**

The period of duration is perpetual.

***ARTICLE III***  
**PURPOSE**

- A) This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. This corporation is organized and operated exclusively for Education and Charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. This corporation is organized for charitable purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of but shall not limited to: Job Training, Job Placement, Land Acquisition, housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Tutoring, AIDS, Elderly Care and other programs to aid those in need.
- B) Not-Withstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code.

***ARTICLE IV***  
**REGISTERED OFFICE/AGENT**

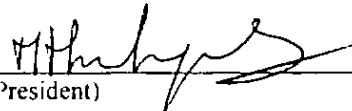

**INDEMNIFICATION**

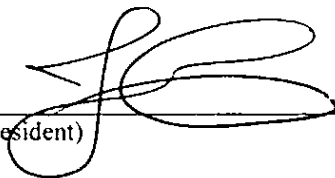
