Notwithstanding any other provisions of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax code, or (b) by an organization contributions to which are deductible under section 170(c) (2) of the Code, or corresponding section of any future federal tax code.
- 3. Upon the dissolution of the organization, the Board of Trustees shall, after paying or making provisions for the payment of all the liabilities of the organization, dispose of all the assets of the organization exclusively for the purpose of the organization in such manner, or to such organization, or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes or shall at the time qualify as an exempt organization within the meaning of section 501(c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose, Any such assets not so disposed of shall be of by Court having proper jurisdiction in the county where the principal office of the organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
