ARTICLES OF INCORPORATION

OF

CITIZENS FOR EFFECTIVE LAW ENFORCEMENT, INC.

The undersigned subscribes to these Articles of Incorporation for the purpose of forming a corporation not-for-profit pursuant to the provisions of the Florida Not for Profit Corporation Act, Chapter 617, Florida Statutes.

ARTICLE I

The name of the corporation shall be "Citizens for Effective Law Enforcement, Inc." The principal street address and mailing address of the corporation is: 2910 Kerry Forest Parkway, D4-315, Tallahassee, Florida 32309.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The primary purpose for which this corporation is created and maintained shall be to conduct political activities, including support of or opposition to candidates, and other exempt functions as permitted pursuant to Section 527 of the Internal Revenue Code of 1986, as amended. The corporation may register as a political committee or other type of political organization as authorized by the provisions of Florida law.

ARTICLE IV

The street address of the initial registered office and the name of the initial registered agent are as follows:

ARTICLE V

The corporation shall be no fewer than three directors. The manner in which the directors are elected or appointed shall be as provided in the bylaws; provided, however, that the initial directors shall be appointed by the incorporator.

ARTICLE VII

The corporation may select the following officers to govern its day to day affairs: President/Chair and Treasurer. The bylaws may provide for additional officers. The initial officers shall be appointed by the incorporator.

ARTICLE VIII

These Articles of Incorporation shall become effective upon filing with and approval by the Secretary of State as indicated by an endorsement hereon with the date and time of approval set forth on a duplicate and may be amended in any manner consistent with Florida Law; provided, however, every amendment shall be approved by the board of directors by at least a majority vote.

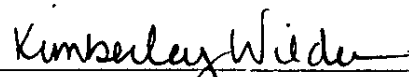

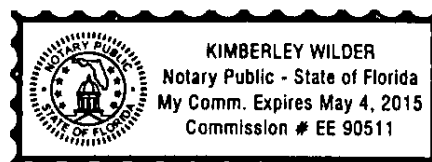
