**CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION OF
ESPLANADE AT HACIENDA LAKES HOMEOWNERS ASSOCIATION, INC.**

(A Florida corporation not for profit)

Pursuant to Chapter 617.1006 of the Florida Not For
Profit Corporation Act

Article XIII(C)1(c) of the Articles is hereby amended to read as follows:

1. (c) At such meeting, a vote of the Members shall be taken on the proposed amendment(s). The proposed amendment(s) shall be adopted upon receiving the affirmative vote of ~~a majority of the total number of Members in the Association~~ **at least two-thirds (2/3) of the voting interests, present and voting, in person or by proxy at a meeting at which a quorum is present and called for that purpose.**
