

ARTICLE I NAME

The name of the corporation shall be: **Fort Pierce Faith Church of The Nazarene, Inc.**

ARTICLE III PURPOSE

This corporation is formed for the following purposes ;

(A) To spread the Gospel of Jesus Christ, promote holiness and the worship of God among its members and attendants, and practice the Christian virtues inculcated in the Holy Scriptures, and in aid thereof to acquire, own and hold by purchase, lease, gift, legacy, bequest, devise or otherwise, both real and personal property of every kind and nature, and dispose of same in any and every lawful way, and use the proceeds thereof for the purposes hereinbefore stated, or reinvest in other property, and to borrow money if need be, and hypothecate its securities, issue bonds, execute promissory notes, mortgages and all manner of conveyances, and the property of this Corporation shall at all times be held, arranged and disposed of in accordance with the current MANUAL of the Church of The Nazarene,

(B) To employ and discharge ordained ministers of the Gospel, and others, to conduct and carry on divine services at the place of worship of the members of the Corporation, and elsewhere, and to collect and disburse any and all necessary funds for the maintenance of said Corporation and the aforesaid ecclesiastical body known as Fort Pierce Faith Church of The Nazarene, Inc, and the accomplishment of its purposes, and further to comply with and conform to the principles and usages set forth in the current Manual of the Church of the Nazarene.

(C) To do all and everything necessary, suitable and proper for the accomplishment of any of the purposes, or the attainment of any one or more of the purposes herein enumerated, or which shall at anytime appear conducive or expedient for the promotion of its welfare, and the accomplishment of the purposes herein enumerated.

(D) To conduct, accomplish and carry on its objectives, functions and purposes or any part thereof, within or without the State of Florida.

(E) The specific purposes hereinbefore enumerated shall not be held to limit or restrict in any manner the powers of the Corporation, but in general the Corporation shall have the power to do all things necessary, convenient or incidental to the carrying out of any or all of the foregoing purposes, and to have and exercise all of the rights, powers and privileges conferred or permitted by the

laws of Florida upon Corporations formed under ("The General Not-For-Profit Corporation Act") including all Amendments thereto.

(F) Current Manual of The Church of The Nazarene states, "upon dissolution, the assets of the corporation shall be distributed to the "District Advisory Board," known as the District Advisory Board of The Southern Florida District Church of The Nazarene, Inc, incorporated in the State of Florida in 1973.

ARTICLE IV MANNER OF ELECTION The manner in which the directors are elected and appointed: _____

(A) The Church Board, (Board of Directors), shall consist of not less than three "3" members of the Corporation duly elected by the members of the Corporation, and shall constitute the said Church Board in accordance with the current Manual of the Church of the Nazarene.

(B) The officers of the Church Board and of the Corporation shall consist of the Pastor of the Fort Pierce Faith Church of The Nazarene, Inc.who shall be ex-officio Chairman of the Church Board, a Secretary and a Treasurer, both of whom shall be elected by the Church Board as provided for in the current Manual of The Church of The Nazarene.

(C) The Church Board of this Corporation shall manage the affairs of the Corporation during the current annual dates as set by the District Church as provided in the current Church of The Nazarene Manual. New Church Board members will be elected at the start of each new church year.
