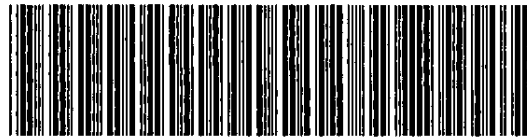

# ARTICLES OF INCORPORATION AND BYLAWS

## Divine Remnant Of Truth Inc.

We, the undersigned, acknowledge and file in the office of the Secretary of State of Florida, these revised Articles of Incorporation, and Bylaws of the Divine Remnant Of Truth Inc.

### ARTICLES 1

#### Name

- 1.1) **Name** -The name of the corporation, shall be **Divine Remnant of Truth Inc.**, and principle office shall be located at 716 Teather Avenue, Deltona, Florida 32738.

### ARTICLES 2

#### Purposes and Powers

- 2.1) **Purposes**-The purpose for which this corporation, is formed are as follows:

- A) To disseminate the Gospel of Jesus Christ and the Word of God, to the end that people may be evangelize and believers may be conformed to the image of Jesus Christ.
- B) To regularly assemble together the members of this congregation for fellowship one with another both in large public congregation and places to worship God in spirit and in truth and to cooperate in the building up the whole body of Christ.
- C) To provide basic New Testament discipleship to all who are approved for this purpose by the Elders.
- D) To involve every participant of this congregation in its fellowship and activities and if the ministry of the Holy Spirit throughout the Body of Christ.
- E) To strengthen the family units so that the home life of each member is healthy and fruitful by Biblical Standards.
- F) To perform the Sacraments of the Church which include, but are not limited to, the following: to baptize believers in water, to anoint the sick with oil; to conduct weddings, and funerals; to dedicate infants; and to celebrate the Lord's Supper (Communion)

- G) To act with charitable concern for and to help, not only members of this congregation, but also all people in need of any help which this congregation can give, regardless of race, social positions or religious affiliations; to develop and carry out programs of social action for poor, widowed, orphaned, afflicted, imprisoned, underprivileged or aged persons, both within and without the congregation.
- H) To pray for the needs of all people, for local and national leaders and government and for all that are in authority as instructed in 1 Timothy 2:1-3.
- I) To support and encourage communication and extension of the Christian life and witness by sound and comprehensive preaching and teaching of Biblical principles to all people both within this congregation and elsewhere, not only by conventional modes but also by all means, which will accomplish such communication, extension, teaching, and preaching. This should include media of communication, developed by modern technology. These purposes should include to sponsor, participate in, conduct or engage in radio broadcasting, television, broadcasting the printing or reproduction and publication of recordings, book and other materials, the establishment, and operation of a school or schools and the holding and conducting of seminars, study groups, workshops, and meetings, by either resident or traveling ministers; to receive offerings for such purposes; and to grant aid and pay reasonable compensation to person, firms and corporations for services actually rendered for such purposes; provided; however, that none of the foregoing shall be done for private profit.
- J) To establish and maintain a place of worship, study, recreation, and social interaction, ministering to the whole family and to the whole person, spirit, soul and body.
- K) To recognize, support and cooperate with the various ministries established by God to equip believers to fulfill their respective functions as members of the Body of Christ and to bring the whole Body of Christ to unity, maturity, and completion.
- L) To provide and maintain homes, places and buildings for housing of such students, lecturers, teachers and ministers, as well as other related members of the corporation; to furnish to such students, lectures, teachers, educators, and ministers suitable meals and lodging.

- M) To acquire either by deed, gift, of purchase, any real estate or personal property to be held in trust for the benefit of the corporation and its stated purposes.
  - N) To mortgage, sell, or otherwise encumber any such property when such action is deemed to be in best interests of the corporation as defined in its stated purposes as a Christian organization.
  - O) To make provision to ordain and license those who have completed satisfactory Bible training and meet all qualifications as set forth by the Elders and have received the unanimous vote of the Board of Elders. Recipients of Ordination and License will be subject to yearly reviews and credentials are subject to termination if recipient fails to meet the prescribed requirements.
- 2.2) **Powers** - To accomplish the foregoing purposes , the corporation shall have all corporate powers permitted under state law, including the capacity to contract, bring suit and be sued. No part of the income of the corporation shall be distributed to the members, directors, and officers of the corporation other than the fair and reasonable compensation ,reimbursements or salaries for services rendered. The corporation is specifically precluded from engaging in any prohibited activities as defined in Section 617.0105, Florida Statutes.

### ARTICLE 3

#### PERIOD OF DURATION

- 3.1) Period of Duration – The Corporation shall have perpetual existence. In the event of dissolution of this corporation the Board shall first pay any and all liability of this corporation. No part of the corporation's assets shall inure to the benefit of any member but shall instead be distributed to any other such charitable organization or organization selected by the final board of Directors of the corporation which preach the Gospel of Jesus Christ and qualify as charitable organizations under Section 170 and 501 © (3) of the United States Internal Revenue Code.

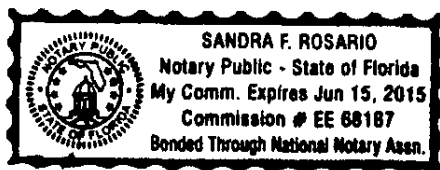


