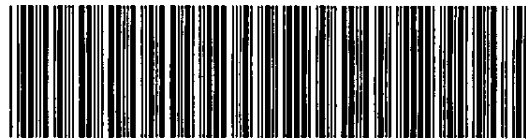

Article VIII. Dissolution

Upon dissolution of this Corporation, the Board of Directors shall, after payment of all the liabilities of the ministry, dispose of all of the assets of the ministry exclusively for the purposes of the ministry in such manner or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall qualify as an exempt corporation or organizations under Section 501(c)3 of the Internal Revenue Code of 1986, as amended (or of the corresponding provisions of any future United States Revenue Law) as the Board of Directors shall determine. No part of the earnings of the Ministry shall inure to the benefit of, or be distributable to its members, officers, directors, or any person except that the Ministry shall be authorized or empowered to pay reasonable compensation for services rendered, and to make payments in the furtherance of the ministry.

Article IX. Miscellaneous

Notwithstanding, any other provisions of the Articles of Incorporation or the Bylaws of the Ministry, the Ministry shall not carry on any activity not permitted to be carried on:

(a) by a corporation exempt from Federal Income Tax, under Section 501(c)3 of the Internal Revenue Code of 1986, as amended (or by corresponding section of any future Revenue Code of the United States of America); or (b) by a corporation, contributions of which are deductible under Section 170(c)2 of the Internal Revenue Code of 1986, as amended (or the corresponding section of any future United States Revenue Law).
