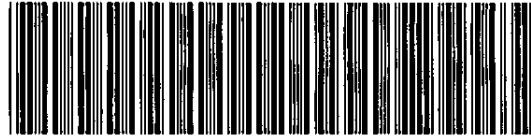

ARTICLE III. The purpose of the ACE Theater Foundation, Inc., is to collect document, preserve and present the rich history of the ACE Theater and its influence on the cultural, economic and political heritage of African Americans in Coconut Grove, Miami, South Miami, Richmond Heights and South Miami-Dade County from the 1880s to the present through permanent/temporary arts/photos and artifacts, exhibits, achieves, recordings, audio/visual experiences, interactive cultural arts, music, dance, lectures, workshops and community outreach education programs, live musical performances and special events for children, teens and adults.

A. This corporation is organized exclusively for charitable and educational purposes under Section 501(c)(30 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

A. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to a candidate for public office. Notwithstanding any provision of these articles, the corporation shall not carry on any activities not permitted to carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

B. Upon dissolution of this corporation, assets shall be distributable to corporation(s) organized for more or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
