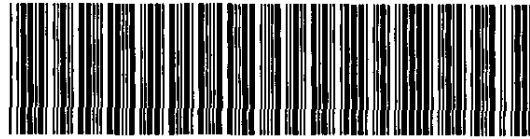

The Warrior's Walk Corporation's purpose is to provide assistance to wounded U.S. Military Veterans by donating financial assistance to help them with their transition into a new lifestyle, recreational equipment, necessary household goods, and medically advanced equipment. Our programs include fundraising events, which include The Warrior's Walk, which is a 222 mile walk across the state of Georgia to raise awareness and donations for wounded U.S. Military Veterans. To maximize our impact on current efforts, we may seek to collaborate with other non-profit organizations which fall under the 501 (c)(3) section of the Internal Revenue Code and are operated exclusively for education and charitable purposes. Upon winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligation of the corporation, if the named beneficiary at the time of dissolution may not be qualified, may not be in existence, or may be unwilling or unable to accept the assets of the dissolving corporation, the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious, and scientific purposes and which has established its tax exempt status under Section 501 (c)(3) of the Internal Revenue Code.
