Pursuant to the provisions of Section 617.1006 of the Florida Not For Profit Corporation Act, JENNIFER ALDEN MINISTRIES, INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I
Name

The name of the corporation is JENNIFER ALDEN MINISTRIES, INC. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on February 13, 2014.

ARTICLE II
Amendment

Article I of the Articles of Incorporation of this Corporation is hereby amended for the purposes of changing the name of the corporation by deleting the existing Article I in its entirety, and substituting the following therefore to wit:
