ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF MADISON PLACE OF POMPANO BEACH HOMEOWNERS' ASSOCIATION, INC

Pursuant to the provisions of Section 617.1006, Florida Statutes, Madison Place of Pompano Beach Homeowners' Association, Inc., a Florida not-for-profit corporation adopts the following Amendment to its Articles of Incorporation:

1. Article Ninth of the Articles of Incorporation of Madison Place of Pompano Beach Homeowners' Association, Inc. is deleted in its entirety and replaced with the following:

Ninth: The officers who are to serve until the first election of the directors are as follows:

President Joyce Villar
Vice President Karl Albertson
Secretary George A. Paliatsos
Treasurer George A. Paliatsos

The first annual meeting of the Corporation and the first election of the Board of Directors shall be held in 2015 by order of the Board of Directors at such date as the Board of Directors may determine, and thereafter annual meetings of the members shall be held within thirteen (13) months of the prior annual meeting at a date and time as determined by the Board of Directors, so long as the day is not a legal holiday, or non-business day. The Directors elected at the first annual meeting and at each subsequent annual meeting of the Members shall elect officers of the Corporation who will hold office until the next meeting of the Board of Directors, or until their successors are elected and qualified.

2. Article Tenth of the Articles of Incorporation of Madison Place of Pompano Beach Homeowners' Association, Inc. is deleted in its entirety and replaced with the following:

Tenth: This Corporation shall be governed by a Board of Directors consisting of not less than three (3) and no more than five (5) persons. The names and addresses of the persons who are to serve as Directors until the first annual meeting of the Members are as follows:

Commencing with the first annual meeting of the Members and at each subsequent annual meeting of the Members of the Corporation, the Directors of the Corporation shall be elected by the Members and they will hold office in each instance until the next annual meeting of the Members or until their successors are elected and qualified. Pursuant to Article Sixth hereof, the Declarant is a Class B Member with three votes for each unsold Lot in the Property. Directors elected by the Class B Member need not themselves be owners of townhomes erected on the property subject to the Declaration nor Members of the Corporation. Further, notwithstanding the number of Class B voters existing from time to time, the Declarant shall have the right to elect all of the Directors of the Corporation until December, 2015. Thereafter the Directors of the Corporation shall be elected at the annual meeting of the Members of the Corporation, which annual meeting will be held pursuant to the provisions of the By-Laws. Vacancies in the Board of Directors shall be filled by the remaining Directors at a special meeting called for that purpose and a Director so elected shall serve until the next annual meeting of the Members of the Corporation.

- 3. That the sole Member of the Madison Place of Pompano Beach Homeowners' Association, Inc. did on May 14, 2015 vote to approve the proposed Amendment in accordance with the Articles of Incorporation and By-Laws of the Madison Place of Pompano Beach Homeowners' Association, Inc. which vote was sufficient for the adoption of said Amendment.
- 4. The date of this Amendment's adoption is May 14, 2015 and this Amendment shall become effective on May 14, 2015.

5. The foregoing Amendment of the Articles of Incorporation of Madison Place of Pompano Beach Homeowners' Association, Inc. was adopted by the Board of Directors of the Association on May 1, 2015.
