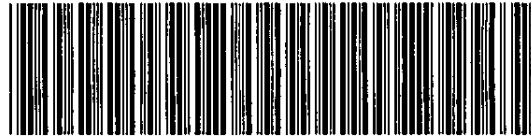


- 6) Continued the "Cup Shall" contain 100% Grape Juice "non-fermented".**
