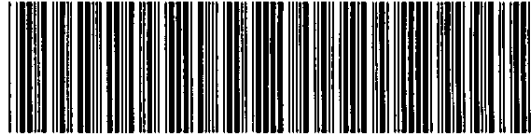

This corporation will secure a venue to serve as a house of worship, acquire a residence for its Spiritual Leader and his family, purchase religious texts and objects for use during worship. foodstuffs for sacred meals, equipment for celebrations, run an office with administrative staff and purchase any other items or services required to grow the community. The Corporation will maintain a charitable fund to assist the needy in any way possible. This House of Worship will adhere to the Laws of Orthodox Judaism as understood in the Chabad Lubavitch Tradition and as understood by its spiritual leader Rabbi Mehanchem M. Spalter, who is the Chabad Lubavitch Emisary to the area. This corporation may itself make contribution to other 501(c)(3) recognized organizations, when so doing will farther this corporation's goals. The original Articles of Incorporation attached to the FL Incorporation Form remain in force. In case of any conflict between this amendment and the previous attachment, this amendment will supersede the attachment.
