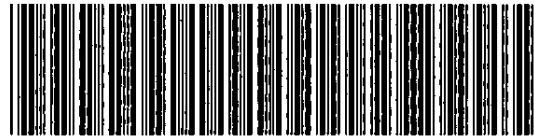

ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, F.S. 617.0202, hereby adopt(s) the following articles of incorporation:

ARTICLE I: NAME

The name of the corporation shall be CITY OF KNOWLEDGE, INC.

ARTICLE II: PRINCIPAL OFFICE

ARTICLE: III PUPOSE(S)

Said organization is organized exclusively for charitable, religious, educational, including the collecting and distribution of faith based charity, for such purposes as to advance religion and Islamic education and to help in eradicating poverty, and making of distributions to organizations, that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of the any future federal tax code.

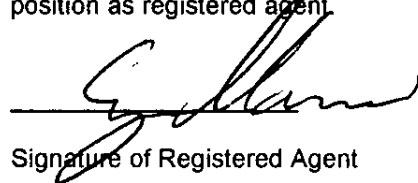
