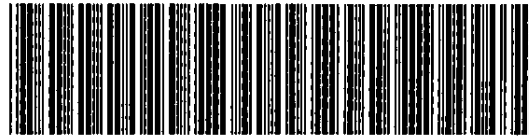

ARTICLES OF INCORPORATION OF PROCLAIM61, INC.

The undersigned Incorporator hereby files these Articles of Incorporation in order to form a corporation ("the Corporation") in compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I NAME

The name of the Corporation shall be Proclaim61, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal street address shall be 3841 Waterview Loop, Winter Park, Florida 32792

ARTICLE III PURPOSE

The Corporation shall be organized as a not-for-profit corporation under Chapter 617, Florida Statutes. The Corporation is organized to engage in exempt activity as described in Section 501(c)(3) of the Internal Revenue Code of the United States, including but not limited to raising public awareness of the problem of human trafficking, which activities are exempt from taxation under such Section. No part of the Corporation's earnings shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the Corporation is authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its purpose.

ARTICLE IV MANNER OF APPOINTMENT OF OFFICERS

In order to be eligible to serve as an officer, the individual must be at least 18 years of age. Officers may be appointed by a majority vote of the directors. The appointment of officers to replace those who have fulfilled their terms shall take place in January of each year.


