Addendum: Dissolution of assets

Duration of the corporation's is perpetual until dissolution. Upon dissolutions of the organization, assets of the corporation shall be distributed for one or more exempt purposes with in the meaning of Section 501(c)3 of the Internal Revenue Code, or corresponding section of any future tax code. All assets shall be distributed to qualified 501(c)3 animal rescue within the State of Florida to be named at final dissolution. No Director or officer shall have any right, title or interest in any property or assets of the Racing4Rescues, Inc during the duration of the corporation or at dissolution. If there are no officers present for the final dissolution the corporation assets should be equally distributed to the following qualified 501(c)3 organizations: Suncoast Animal League, Inc., Daytona Beach German Shepherd Rescue, Inc., and The Bruno Foundation, Inc.
