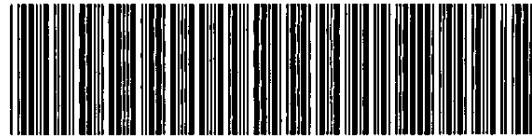

The undersigned, acting as incorporator(s) of a Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation of such corporation:

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of this corporation shall be:

**SRQ YOUTH FOUNDATION, INC.**

The principal place of business of this corporation shall be:

Bradenton, Florida 34212

**ARTICLE II**

The period of the duration of this corporation is perpetual unless dissolved according to law.

**ARTICLE III**

The purposes for which the corporation is organized are:

The corporation will promote a youth sports program in the Manatee/Sarasota area. We wish to instill and encourage the players and raise funds to be used solely for the use of purchasing equipment, obtaining facilities, helping with travel expenses, tournament fees and those things required to run a successful program, which will promote interest from the community, uplifting morale for the program and players. The program will unite together through the membership of the organization, coaching staff and administration with the active participation that will elevate the sports program in our local area.

#### **ARTICLE IV**

The qualifications for members and the manner of their admission are:

The qualifications for members and the manner of their admission are the willingness to promote and participate in the development of soccer in the community and properly registering with sanctioning bodies.

#### **ARTICLE V**

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue code, or corresponding section of any future federal tax code.

## ARTICLE X

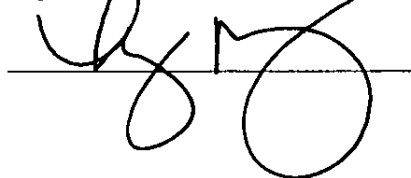
No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

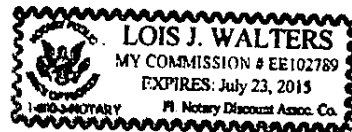

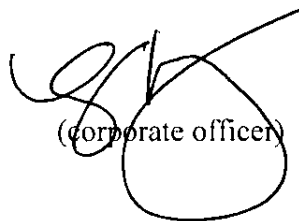

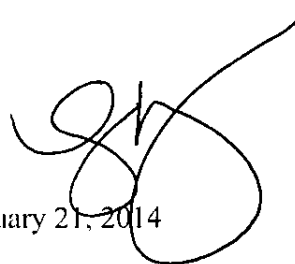
