To build, construct, erect, maintain mission stations and mission churches, pastor's home and such other houses or equipment as the corporation may desire for carrying on its work.

To receive, administer, disburse and/or invest gifts, and requests by or from any persons or corporations.

This corporation is further organized for the purpose of holding the title to such property or properties as the **MINSTERIO UNIDOS EN CRISTO ASAMBLEAS DE DIOS, INC.** shall from time to time purchase or acquire and it shall have power from time to time to make such contracts and do such things as shall be authorized and directed by its members. This corporation shall have the power to mortgage, sell, encumber deed or otherwise dispose of any property, which may belong to the **MINSTERIO UNIDOS EN CRISTO ASAMBLEAS DE DIOS, INC..** This assembly shall have the right to govern itself according to the standards of the New Testament Scriptures.
