**ARTICLES OF INCORPORATION
FOR
SOUTH GORDON DRIVE NEIGHBORHOOD ASSOCIATION, INC.**

The undersigned hereby submits these articles for the purpose of forming a not-for-profit corporation under Chapter 617, Florida Statutes, and certifies as follows:

ARTICLE I. Corporate Name

The name of the corporation is South Gordon Drive Neighborhood Association, Inc., hereinafter called the "Association".

ARTICLE II. Address

The mailing address for the Association shall be 821 Fifth Avenue South, Naples, Florida 34102, Attention: John M. Passidomo, Cheffy Passidomo. The principal office of the Association shall be located at the mailing address or at such other place as may be subsequently designated by the Board of Directors of the Association.

ARTICLE III. Purpose and Powers of the Association

This Association does not contemplate pecuniary gain or profit to the Members thereof and shall make no distribution of income to its Members, Directors, or Officers. The specific purpose for which the Association is formed is to carry on such activities as may be deemed to enhance the civic welfare of the residents of the City of Naples and "South Gordon Drive Neighborhood" as that term is described from time to time in the Association's By-Laws. In addition, the Association shall be empowered to do and perform all acts allowed by the laws of the State of Florida relative to corporations not for profit, as now existing, or as the law may provide in the future.

ARTICLE IV. Membership

Membership in the Association is voluntary, and eligibility requirements and procedures will be set forth in the By-Laws.

All of the Members of the Association are entitled to vote according to the procedures set forth in the By-Laws.

ARTICLE VI. Board of Directors

The affairs of this Association shall be managed and governed by a Board of Directors consisting of no less than three (3) and no more than nine (9) Directors. All Directors of the Association shall be active Members thereof and shall serve without compensation. The number of Directors may be changed by amendment of the Articles of Incorporation of the Association. The Board of Directors shall have general charge and control of the business and affairs of the Association and shall have the power to take such action and make such rules and regulations as shall be necessary to promote the interests of the Association. The term of the Association shall be perpetual.


