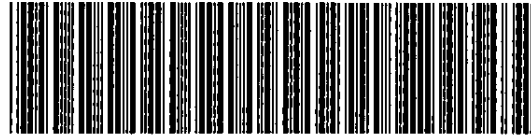

The bylaws will be formulated and implemented by the initial Board of Directors once appointed by the incorporators.

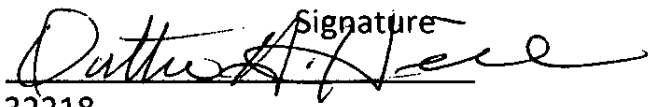
ARTICLE VII

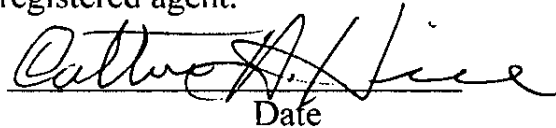
