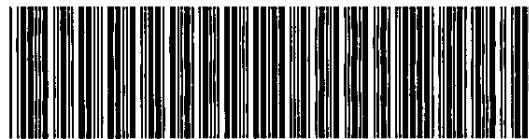

ARTICLE VIII - EARNINGS OF THE CORPORATION

No part of the net earnings of the Corporation shall inure to the benefit of, or distributable to its members or officers or private persons in furtherance of ARTICLE III hereof. No activity, of the Corporation, shall be for any propaganda or influencing legislation, and the Corporation shall not participate in any political campaign for any individual or party. The Corporation shall only engage in furtherance of the purposes of the Corporation.

ARTICLE IX - DISSOLUTION OF THE CORPORATION

Upon the Dissolution of the Corporation, assets shall be distributed to for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code or shall be distributed to the federal government, for a public purpose. Any such assets, not so disposed, shall be disposed of by a Court of Competent Jurisdiction, exclusively for such purposes or to such organization(s), as the said Court shall determine, which are organized and operated exclusively for such purposes.
