ARTICLES OF INCORPORATION OF

This is to certify that we, the undersigned, do hereby associate ourselves together under and by virtue of the laws of the State of Florida set forth in Chapter 617 of Florida Statutes, for the sole purpose of organizing a non-profit corporation and to that end do hereby set forth the following:

ARTICLE I: NAME
