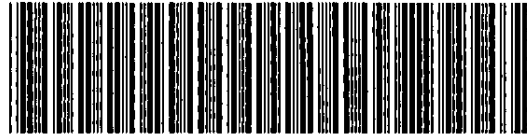

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation in compliance with Chapter 617, F.S., (Not for Profit), do hereby certify:

First: The name of the Corporation shall be The Wu Project, Inc.

Second: The incorporators of the Corporation are:

- (1) Alicia Villamarin, 300 Mallard Road Weston, FL 33327
- (2) Maria Rosa Romero, 742 10th St Apt. 109 Miami Beach, FL 33139
- (3) Andrew Newman, 300 Mallard Road Weston, FL 33327

Third: The principal office of the Corporation is to be located at 300 Mallard Road Weston, FL 33327.

Fourth: The name and street address of the registered agent is Andrew Newman at 300 Mallard Road Weston, FL 33327.

Fifth: The Corporation will have no members.

Sixth: The purpose for which The Wu Project, Inc. is organized is to bring health care, medical training and hope to communities in need around the world using Oriental Medicine principles.

Said Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

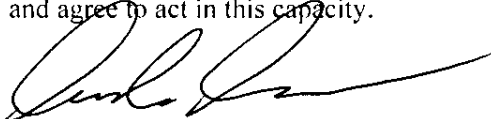

Tenth: No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Sixth hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a Corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Eleventh: Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

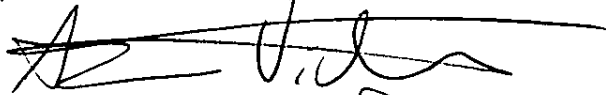

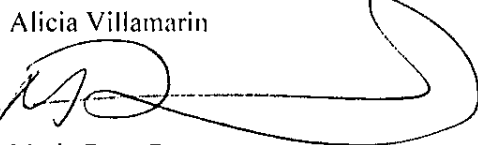

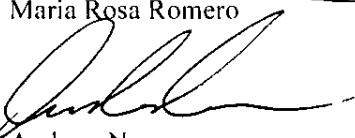
