ARTICLES OF INCORPORATION OF

SOCCER FOR GOOD, INC.

The undersigned incorporator, for the purpose of forming a corporation understand the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

- 1. The name of the Corporation is **SOCCER FOR GOOD, INC.**
- 2. The principal street address of the principal office and place of business is:

6622 South Point South Ste 350 Jacksonville, Florida 32216.

3. The specific purpose for which the corporation is organized is to create opportunities for the development of young men and women in the areas of character, physical fitness, health, sports related activity, and community service

The specific purpose is to create financial support to educational research contributing to the growth of the game by bringing together the greatest minds in the game to continue its work begun by Dr. Thomas Fleck, the US Soccer National Youth License and other similar initiatives

The specific purpose is to support the entire soccer community (participants of all race, crede and gender,) fans, organizations, growth and development of corporate citizens, city state and national government programming, amateur and other soccer organizations or educational organizations with soccer

The specific purpose is to assist young men and women with housing, jobs, character and spiritual development for young men and women

The specific purpose is to connect local, state and national YMCA's, Ministries, Youth Programs internationally helping the needy and raising educational standards, assisting the impovershed, the handicapped and special needs population through the world's game soccer

The specific purpose is to create peace and relationships amongst children playing soccer locally then globally to create good will in all communities

The specific purpose is to create funding for faith based education through coaches and the game of soccer (example... Coaches Honor)

The specific purpose create facilities and financial support for existing and new soccer programs locally and globally

The specific purpose is to create and motivate community awareness to be physically fit through soccer events and the soccer community

- 4. The manner in which the directors are elected or appointed is that the directors are appointed by the incorporator and thereafter the directors are elected pursuant to the Bylaws of the corporation.
- 5. The name and Florida address of the initial registered agent are:

- 6. This organization is a nonprofit charitable, educational, and religious organization and is not organized for the private gain of any person. It is organized exclusively for charitable, educational, and religious purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- 7. No substantial part of the activities of this organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, except as otherwise provided by Section 501(h) of the Internal Revenue Code, and the organization shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

- 8. The property of this organization is irrevocably dedicated to charitable, educational, and religious purposes. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to, its directors, officers, members, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.
- 9. Notwithstanding any other provision of these articles of incorporation, this organization shall not engage in any activities or exercise any powers that are not in furtherance of the purposes of this organization, and the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- 10. Upon the dissolution of the organization, assets remaining after payment, or provision for payment, of all debts and liabilities of this organization, shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to a nonprofit fund, foundation or organization which is organized and operated for charitable, educational, and religious purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
