CERTIFICATE OF INCORPORATION

OF

Article I: Name

The name of the Corporation is ***The Broken Bird, Inc.***, hereinafter sometimes called "the Corporation".

Article II: Place of Business

The office of the Corporation is to be located at:

***5024 Manduria Street
Orlando, Florida 32812***

Article III: Purpose

The purpose of the Corporation shall be to provide counseling, peer support, life/coping skills and resources to the people who are homeless, have addiction and or abuse issues in our community and to serve as a catalyst for community change and collaboration to end their lack of support. The Corporation is not formed for pecuniary profit or financial gain. The Corporation is organized exclusively to provide access to Human Services, to the public at large, with funds primarily obtained from governmental or foundation grants, or public or public support.

The purpose or purposes for which the Corporation is organized are as follows:

1. To be a not for profit Corporation, without Capital Stock, which shall be operated exclusively for educational and charitable purposes.
2. To provide Peer-Based Support Services to individuals, recovering from homelessness, addiction or abuse issues, in our community.
3. To educate the public at large concerning the needs and issues of individuals who suffer from homelessness, addiction or abuse, in our community.
4. To provide a forum for the exploration of new Peer-Based Support Service applications, for individuals recovering from Substance Addiction, Homelessness and Abuses in our community, and to stimulate collaboration among the public at large, to achieve this goal.

5. Notwithstanding anything to the contrary contained herein or in the by- laws, the corporation has been organized exclusively for educational and charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Internal Revenue Code"). Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
6. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.
7. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Article IV: Dissolution of Corporation

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article V: Board of Directors

The Corporation shall be operated by a Board of Directors, who shall be elected at the Initial Organization meeting of the Corporation, as per appropriate sections under Robert's Rules of Order.

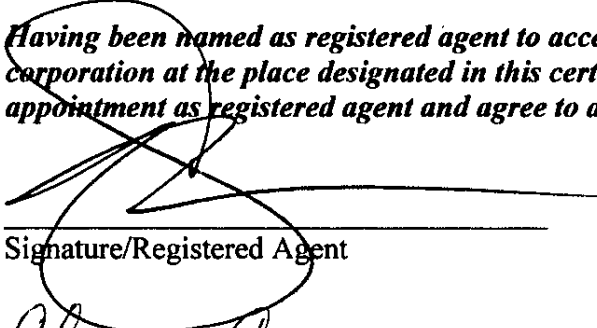
