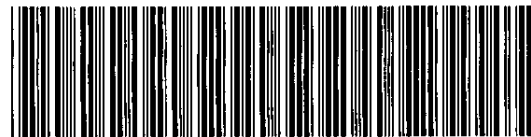

The undersigned for the purpose of becoming incorporated under the laws of the State of Florida applicable to corporations not for profit under the Florida Statutes, and for this purpose, hereby makes, execute and adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is the **SOUTH MARION LAND ASSOCIATION, INC.**

ARTICLE II. TERM OF EXISTENCE

The term of existence is perpetual. Corporate existence will begin when the corporation is filed with the Secretary of State.

ARTICLE III. PURPOSES
